## **EXECUTIVE ORDER NO. 15**

## "AN ORDER CREATING THE BANGON RIVER WALK (BRW) MANAGEMENT COMMITTEE OF THE MUNICIPALITY OF PALO, LEYTE"

**WHEREAS**, pursuant to RA. NO. 7160, otherwise known as the "Local Government Code of 1991", the local government units (LGUs) are mandated to share with the national government the responsibility of managing its natural resources;

**WHEREAS**, Promenade is a long, open, level area, usually next to a river or large body of water, where people may walk.

**WHEREAS**, the area surrounding a river, lake, lagoon or sea coast acts as a transition zone between water and land. Therefore, turning the water banks into dynamic and appealing public spaces helps to establish a certain balance between the stiffness of the built environment and the fluidity of water.

**WHEREAS**, the Local Government Unit of Palo with the construction and the redevelopment of rivers for flood protection barrier re-connects its river promenade with the surrounding serving as a popular riverside walkway while also creating links with adjacent neighborhoods to protect the municipality from maximum storm surges and extreme high tides;

**WHEREAS**, in compliance with the Local Government Code of 1991 and in the exigency of the service, the efficient and effective implementation of programs and projects is eminent, thus the need to create the Bangon River Walk management committee.

WHEREAS, NOW THEREFORE, I, FRANCES ANN B. PETILLA, Municipal Mayor of Palo, by virtue of the power vested in me by law and the constitution, hereby order as follows:
